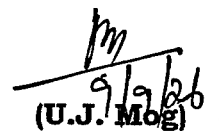

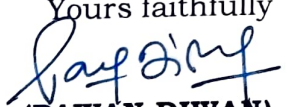
I am directed to refer to your letter dated 04.09.2026 requesting therein deferment of the schedule of Special Intensive Revision (SIR) in the State of Tripura in view of the announcement of General Elections to all the Village Committee constituencies, 2026, under the Tripura Tribal Areas Autonomous District (TTAADC). The Commission has approved the proposal made therein.

2. The revised schedule of the SIR exercise in Tripura with respect to 01.01.2027 as qualifying date shall be as follows:

SIR Activity	Revised Schedule
Preparation, Training & Printing	27.10.2026 to 05.11.2026
House to House visits by BLOs	06.11.2026 to 05.12.2026
Rationalization / Rearrangement of Polling Stations	By 05.12.2026
Publication of draft electoral roll	12.12.2026
Period for filing claims & objections	12.12.2026 to 10.01.2027
Notice Phase; disposal of claims and objection	12.12.2026 to 09.02.2027
Final Publication of Electoral Roll	15.02.2027

3. EROs shall also invite advance applications for subsequent qualifying dates i.e. 1st April, 1st July & 1st October, 2027 while publishing notice for draft publication in Form-5.

4. All the remaining guidelines issued vide Commission's SIR order dated 14.05.2026 referred to above shall remain the same and apply in the state of Tripura.
